

**Range Road Dachshunds; HEALTH GUARANTEE**

This puppy has been examined by us and a licensed veterinarian prior to purchase, and is hereby warranted to be in good health to the best of our knowledge. TO KEEP THIS LIMITED WARRANTY IN EFFECT, the purchaser is directed to immediately contact a licensed veterinarian to arrange for an examination within ten (10) days of the date the puppy is received. This is to protect the purchaser, the buyer and the dog.

Should a health defect be found that will affect the quality of life or life span of the dog; It is intended that a replacement puppy will be offered rather than a refund. *(The reason for full replacement is that we do not want to leave the buyer with a financial liability if there was something we knew about before the end of the warranty period. Genetics and mutations of such are not in our control past our vetting of the breeding parents. We try our best to make good breeding choices. We would hope that the buyer understands that this is not a standard retail transaction and that health varies from one pup to another even out of the same litter. You the buyer are taking on the responsibility of caring for this pup and part of this care will include the cost of regular veterinarian visits.)* We the Seller reserve the right to adjust this “refund” protocol in the spirit of making things easier on the purchaser if in mutual agreement between the two parties. This can include covering the cost of veterinary expenses for treatment of pre-existing conditions that existed before the dog left our care.

***PURCHASER SHALL BE RESPONSIBLE FOR ONGOING VETERINARY EXPENSES INCURRED FOR ANY REASON ONCE THE PUPPY IS IN THE HANDS OF THE PURCHASER.***

All warranties of disposition, show quality, breedability, or descending are hereby excluded. Seller will not accept any exchanges for any reason not related to the health or wellbeing of the dog.

**1 YEAR LIMITED WARRANTY**

This dog is warranted against debilitating, hereditary & congenital defects, including hip dysplasia, for a period of twelve(12) months from the date of sale. To activate this warranty, purchaser must give notice in writing to seller within twelve(12) months of purchase together with a copy of a certified veterinarian's written diagnosis. At the option of the seller, a second opinion by a veterinarian of seller's choice will be given. Cost of x-ray's is the responsibility of the purchaser. The liability of seller is limited to the replacement of the animal.

## **6 MONTH DISTEMPER AND HEPATITIS LIMITED WARRANTY**

In the event your puppy should die from either Distemper or Hepatitis WITHIN SIX(6) MONTHS from the date of purchase and the purchaser has acquired all the necessary boosters following purchase, Range Road Dachshunds will replace the puppy with a puppy equal to the original purchase price, provided purchaser and their veterinarian have complied with the requirements listed below. Purchaser shall be responsible for veterinarian expenses incurred.

*NOTICE TO VETERINARIANS:* In order for the Distemper and Hepatitis warranty to be valid these requirements must be met; 1) The puppy must have three (3) timely canine distemper and hepatitis vaccinations in the total recommended series. The manufacturer and dates of administration must be recorded on the shot record. 2) In the event the described puppy should die from canine distemper or hepatitis, this warranty will not be effective without complete written health history including all laboratory, post mortem findings, and histopathology reports from the veterinarian reference laboratory.

### **ADDITIONAL ITEMS**

Range Road Dachshunds does guarantee against Internal Parasites within 7 days, provided a fecal exam has been done by your veterinarian at purchaser's expense. Should a positive test be provided the cost will be covered by the guarantee.

Range Road Dachshunds does not guarantee against hypo-glycemia, as this condition depends on the care given by the purchaser, after the puppy has left our possession. *(Keeping a vigil eye on your puppy, especially when they are young, is an important factor in preventing hypoglycemia. Providing proper nutrition and feeding on a routine schedule is very important).*

### **BUYER'S PROMISE**

Buyer agrees to have above dog spayed/neutered. Breeding of the dog stated in this contract is not allowed. Buyer agrees that the adopted puppy will be solely owned and housed by the Buyer for the duration of the puppy's life. If the adopted puppy ever needs a new home—for any reason—it is agreed that the buyer will contact the seller who will be able to properly vet the new owner. No refund will be made for returning the adopted puppy to the Seller other than what is stated in the above noted warranties. The Buyer also agrees to treat the adopted puppy with kindness and to provide a healthy and safe home.
